Instrument Rent-to-Own Program

Why rent from Saxophone.com?

- When you rent an instrument from Saxophone.com you are renting from experienced professional players who know their instruments inside and out!
- The Saxophone.com instrument rental program has no minimum rental period.
- If you purchase our **Damage Protection Plan** we'll repair or replace your horn at no cost (see exclusions within rental terms).
- Saxophone.com will apply 100% of rental payments (even shipping fees!) toward purchase of the rental instrument (see rental terms for more details).
- In addition to renting student/intermediate level saxophones, Saxophone.com now offers **Clarinets** and **Flutes**, as well as professional instruments including our "Classic" gold lacquered and "Vintage" un-lacquered **Baritones**, lacquered and "Custom" black Nickel **Sopranos**, as well as "Custom" **Altos** and **Tenors** (subject to availability).

The Process

1. Read the **Rent-to-Own Terms and Conditions Agreement** (page 2 &3), sign your name and date the form as your acceptance of our policies.
2. Fill out the **Rental Instrument/Accessory Order Form** (page 4) in it's entirety (either by hand or by computer entry), making sure to include a valid credit card for the initial and re-occurring monthly payments and sign where indicated as authorization for Saxophone.com to charge your credit card.
3. Print both the **Rent-to-Own Terms and Conditions Agreement** and the **Rental Instrument/Accessory Order Form** and either mail or fax it to us (above address). We will verify your information, process your credit card payment and prepare your horn for shipment right away.

Rent-to-Own Terms and Conditions Agreement

Rental

All instruments come ready to play with mouthpiece, reed, strap and case (as applicable to instrument chosen).

You may rent the instrument for as long as you wish on monthly basis.

The instrument may be returned at any time with 30-day written/e-mail notification.

Upon termination of rental agreement, instrument and all rental accessories should be packaged in the original packaging from Saxophone.com, insured for \$500 and shipped back to Saxophone.com via priority mail to the address listed above. If original packaging was not retained, please call 1-800-COOL-SAX for packaging instructions.

Upon receipt of a returned instrument, Saxophone.com will return the security deposit less repair for any damage deemed to be outside of normal wear and tear.

During the rental period the ownership "title" of the instrument remains with Saxophone.com.

Rental instruments may be new or previously rented. Please note that previously rented instruments have been thoroughly shop adjusted and sterilized.

Rent-to-Own

The rental saxophone can be purchased any time before the contract is paid off. Should you choose this option, the price of the saxophone will be 50 % off the list price. Saxophone.com will apply 50% of the payments made so far to this price.

Past Due Accounts

On a monthly basis, the credit card provided upon initial rental will be charged for the monthly rental and damage protection (if chosen). If credit card payment should fail for any reason, we will contact you for replacement card information. If a valid credit card is not provided, the rental contract will be terminated and the instrument must be returned to Saxophone.com.

Damage Protection Plan

For the fee of \$3 per month (Clarinet, Flute, Beginning Alto, Beginning Tenor, Intermediate Alto, Intermediate Soprano), \$4 per month (Intermediate Tenor), \$5 per month (Pro Alto, Pro Soprano, Pro Tenor, and \$6 per month, Saxophone.com will assume the expense of returning a damaged instrument to proper playing condition without charge unless damage is proven to be intentional or based on mischievous conduct. Coverage does not apply to deterioration of appearance, which

does not affect the performance of the instrument, such as scratches, minor dents and finish. Presence of such damage, if proven to be beyond normal wear and tear, will result in retention of the security deposit.

Reeds and mouthpieces are excluded from coverage.

Saxophone.com must make all repairs and replacements at our facility.

Renter will pay the cost to ship the rented instrument back to Saxophone.com for repair via insured priority mail (insured value of \$500). Saxophone.com will incur the cost to ship the instrument back to the renter. Should the repair take longer than one week, Saxophone.com will replace the rented instrument with one of similar quality in order to minimize loss of playing time.

Whenever possible, instrument should be shipped back to Saxophone.com using the original packaging it arrived in from our facility.

Shipping

Shipping fees will be added to the initial payment for all instruments. The renter will also incur a return-shipping fee (plus insurance of \$500) to return the instrument at the end of the rental. Any accessories ordered at the time of rental will be shipped at no additional charge. Shipping is via USPS Priority Insured.

Security Deposit

A one time security deposit will be collected as part of the initial payment for all rentals per the rental price list (page 4). Upon receipt of an instrument at the end of the rental, the instrument will be inspected for damage. If no damage is present, the security deposit will be returned within 30 days. If there is damage to the instrument, the security deposit will be retained to cover the cost of repair.
